lending company3 10 million Naira), so far the majority of DPAs have focused on providing authorizations for data transfers. For example, since its establishment in 2015, the National Commission of Data Protection (CNPD) in Cape Verde has issued 1307 authorizations4, but there are no fine or penalty decisions published.

However, some DPAs were established long after the laws were enacted. For example, Azerbaijan's DPA recently became operational, 10 years after its law was enacted. The Georgian DPA's enforcement powers vis-á-vis the private sector only began in late 2014, three years after the law was enacted.
