What is the Puerto Rico solar access program?

The Solar Access Program is funded by the U.S. Department of Energy's Puerto Rico Energy Resilience Fund. For far too long, Puerto Ricans have lived with an unreliable and expensive electric system.

How much money does Puerto Rico have to pay for solar?

Up to \$190 millionis available to Puerto Rico's Housing Administration and a private company to pay for solar and battery installations in public housing common areas and subsidized,multifamily housing properties. Another \$175 million is available for certain healthcare and dialysis centers.

What is the Puerto Rico energy Resilience Fund?

This program, funded through the Puerto Rico Energy Resilience Fund, will provide solar panels and battery storage systems to low-income households in Puerto Rico with zero upfront costs, as well as education and support on how to use and maintain the systems.
