Bermuda''s firewall legislation applies to "Bermuda trusts" which is now defined to include trusts that are in part governed by Bermuda law as well as trusts that are wholly governed by Bermuda law; clarification that that Bermuda courts i.e. all courts of Bermuda (including appellate courts) have jurisdiction in respect of Bermuda trusts; ...

The simplification of Bermuda's firewall legislation has been achieved in the Amendment Act by providing for an exclusion of foreign law where appropriate as opposed to providing for a blanket application of Bermuda law subject to exceptions.
