What is the EU solar energy strategy?

In May 2022, the European Commission adopted a new European Union (EU) Solar Energy Strategy aiming to ensure that solar energy achieves its full potential in helping to meet the European Green Deal's climate and energy targets. A goal of the strategy is to reach nearly 600 GW of installed solar photovoltaics (PV) capacity by 2030.

Will Europe reach 600 GW of installed solar photovoltaics by 2030?

A goal of the strategy is to reach nearly 600 GWof installed solar photovoltaics (PV) capacity by 2030. While Europe is a pioneer in the definition of new policy requirements to ensure the circularity and sustainability of PV products, its manufacturing capabilities are limited.

Will solar power be a major engine of Europe's energy transition?

Solar power promises to be a major engine of Europe's energy transition. By 2030,European Union countries aim to reach the target of almost 600 gigawatts 1 of installed solar photovoltaic (PV) capacity as set out in the European Union's Solar Energy Strategy (European Commission,2022a) - up from around 263 GW today 2.

How has global solar PV manufacturing capacity changed over the last decade?

Global solar PV manufacturing capacity has increasingly moved from Europe, Japan and the United States to Chinaover the last decade. China has invested over USD 50 billion in new PV supply capacity - ten times more than Europe - and created more than 300 000 manufacturing jobs across the solar PV value chain since 2011.

Does the EU import solar PV modules from China?

The EU mostly imports PV modules from China, which for the last decade has remained the global leader in PV manufacturing across the supply chain. This article aims to provide insight into the solar PV industry and the surrounding policy context, focusing on the manufacturing phase and its climate impact.

How many dumping and import taxes are imposed on solar PV?

Since 2011,the number of antidumping,countervailing and import duties levied against parts of the solar PV supply chain has increased from just 1 import tax to 16duties and import taxes,with 8 additional policies under consideration. Altogether,these measures cover 15% of global demand outside of China.
