What is France's energy sector?

France's energy sector is dominated by fossil fuels and nuclear energy; the latter of which France is the most strenuous supporter and largest producer in Europe.

Should France make it easier to develop solar & wind projects?

France must make it easier to develop solar, wind and battery projects or lose out to neighbours, the CEOs of French oil major TotalEnergies and state-owned EDF said on Tuesday at the French electricity union (UFE) annual conference.

Will France produce more low-carbon electricity in 2023?

France is a leader in this area. Thanks to its nuclear energy production, it now has one of the electricity systems with the lowest CO<sub>2</sub> emissions in Europe. But electrification means that France will have to produce much more low-carbon electricity in the coming years. However, in 2023, France isn't producing any more than it did 20 years ago.

What will France's energy system look like in 30 years?

France's energy system is about to undergo an unprecedented revolution. In fewer than 30 years, everything must change: no more oil and gas imports; a lot more solar panels, wind turbines and bio-energies. Gone will be the gas stations and oil-fired boilers, replaced by electric vehicles, bicycle paths, and heat pumps.

Will France have a nuclear power plant in 2040?

Over the next 15 years, France will only be able to rely on solar and wind power to increase its capacity. It still has 18 nuclear power plants, but their output has been falling for several years: At best, it could rise slightly by 2030. The new reactors promised by the government, if they are built at all, will not go online until 2040.
