Do you need planning permission to install solar panels?

Current rules that require businesses to apply for planning permissionif solar panels will generate more than one megawatt of electricity will also be scrapped, meaning organisations will be able to install more solar panels on rooftops without the delay and cost of applying for planning permission.

Do solar farms need planning permission?

Below this threshold, solar farms will require planning permission from the local planning authority (LPA); under the Town and Country Planning Act 1990, LPAs are responsible for renewable and low carbon energy development of 50 MW or less installed capacity.

Do solar panels comply with building regulations?

Your solar panel system must comply with building regulations in terms of structural integrity, electrical safety and fire safety. These regulations may vary depending on the size and type of the installation. It's advisable to work with accredited installers who are familiar with these requirements.
