Do I need a certification to install a solar PV system?

It is a requirement for every solar PV system to have certification. Once your solar PV system is installed, the final prerequisite to completing your installation is obtaining one of these certificates which grants approval to connect to the national grid. Are they mandatory? Yes, it is mandatory to obtain a G98/G99 certificate.

How many hours does a PV installer need?

According to NABCEP, a PV installer must complete a minimum of fifty-eight (58) hoursof advanced training. Forty (40) hours of this training must be with an accredited institution and cover 'advanced' PV installation and practices as outlined in the NABCEP PV Installation Professional Job Task Analysis (PVIP JTA).

Do solar PV installations need to be MCs certified?
