

## Photovoltaic inverter bidding standard requirements

Are there any UK standards relating to a PV installation?

While many UK standards apply in general terms, at the time of writing there is still relatively littlewhich specifically relates to a PV installation. However, there are two documents which specifically relate to the installation of these systems that are of particular relevance:

What are the requirements for a PV installation?

Virtually all domestic PV installations will fall under the scope of Part P. Part P requires the relevant Building Control department to be notified and approve the work. There are two routes to comply with the requirements of Part P: Notify the relevant Building Control department before starting the work.

What are the requirements for a power inverter?

Inverter should meet the requirements specified in IEEE Std. 929-2000or other national standard or the interconnecting utility requirements. Phase current imbalance should be less than 5% measured at 50% and 100% rating. Unbalanced phase currents may cause overheating of the utility transformer.

Are all PV products covered by IEC61730 'photovoltaic (PV) module safety qualification? In future it is expected that all PV products will increasingly be coveredby International standard IEC61730: 2004 'Photovoltaic (PV) module safety qualification'.

Should green public procurement criteria be included in tenders for solar PV installations?

Further examples of the inclusion of Green Public Procurement criteria in calls for tender for solar PV installations are requested. MEErP concept: analysis of the direct and indirect impacts of an Energy related Product (ErP) on associated energy systems.

What standards are available for the energy rating of PV modules?

Standards available for the energy rating of PV modules in different climatic conditions, but degradation rate and operational lifetime need additional scientific and standardisation work (no specific standardat present). Standard available to define an overall efficiency according to a weighted combination of efficiencies.
