Should solar PV projects be aligned with the PPA?

Are solar photovoltaic power plants the future of power generation?

Although it currently represents a small percentage of global power generation, installations of solar photovoltaic (PV) power plants are growing rapidly for both utility-scale and distributed power generation applications.

What should be considered when promoting a PV power generation project?

Second, regardless of what type of PV power generation project is promoted, all four stages of the PV power generation project should be considered, particularly the operation and oversight stages. Policy instruments should match the stages of the PV projects.

How government supports PV power generation projects?

In the initial project construction stage, financial support is the most commonly used policy instrument. In the operation phase, electricity sales policies are the main policies. Government supports different forms of PV power generation projects at different stages according to its policy orientation.

How can a capital grant help a solar PV project?

Capital grants awarded through a tender or application process have also helped support solar PV projects, especially in the early stages of PV power commercialization when its costs were very high, the awareness of its characteristics limited, and the perceived risks high.

Why is PV power generation not a stable power source?

In addition, as PV power generation influenced by the environment is constantly changing and is not a stable power source, the power grid limits the power generated by the PV power plants and even rejects access by the PV system for safety. Fig. 2 shows China's curtailed PV power generation and brownout from 2015 to 2018.
