Will Puerto Rico get a solar power plant?

The money will finance construction of two solar photovoltaic (PV) farms equipped with battery storage, and two standalone battery energy storage systems (BESS), in Puerto Rico. The facilities will be located in the municipalities of Guayama (Jobos) and Salinas and will help deliver power throughout Puerto Rico.

Who is developing Puerto Rico's energy grid?

Development is led by Clean Flexible Energy, an indirect subsidiary of AES Corp. and TotalEnergies Holdings USA. A conditional loan guarantee was announced for the project in July. Puerto Rico is aiming to eliminate coal-fired energy generation by 2028 and develop a 100% renewable energy grid by 2050.

How much solar power does Puerto Rico need?

It would add up to 200 megawatts of solar generation and another 285 megawatts of storage capacity to Puerto Rico's grid, according to U.S. Energy Secretary Jennifer M. Granholm. The solar photovoltaic project is expected to generate about 460,000 megawatts of energy, enough to power some 43,000 homes, officials say.

Will Puerto Rico build two solar photovoltaic farms?

SAN JUAN, Puerto Rico (AP) -- The U.S. Department of Energy announced an \$861 million loan guarantee on Wednesday to build two solar photovoltaic farms in Puerto Rico as persistent power outages plague the U.S. territory.

What percentage of Puerto Rico's electricity comes from fossil fuels?

Fossil fuels currently generate 94% of Puerto Rico's electricity, with the island tasked with obtaining 40% of its energy from renewable sources by next year and 60% by 2040. The Associated Press is an independent global news organization dedicated to factual reporting.
