Will South Korea expand carbon-free energy supply?

South Korea's Ministry of Trade, Industry and Energy (MOTIE) announced plans to expand carbon-free energy (CFE) supplyto boost export competitiveness and meet global carbon regulations.

How can South Korea reduce energy consumption?

As the world's seventh-largest energy-consuming nation (2022), South Korean officials are actively pursuing ways to reduce energy consumption while shifting towards more environmentally friendly sources. U.S. companies have opportunities in providing energy solutions including energy related engineering services.

What does the Korea Trade Ministry do?

The ministry also works to encourage foreign investment in Korea. The current minister is Ahn Duk-geun, the former Head of the Trade Negotiations Division (as a 1st Deputy Minister) in the Department from May 2022 to January 2024. The ministry began in 1948 as the Ministry of Commerce during the First Republic.

Does the CFE initiative address South Korea's energy transition needs?

However, given South Korea's limited targets and significant infrastructure and financial challenges in transitioning to clean energy, it remains to be seen if the CFE Initiative may sufficiently address the country's energy transition needs or protect its economic competitiveness and international standing.

What percentage of Korea's power generation mix should be nuclear?

Under the scheme, the percentage shares of power generation mix by energy source should be nuclear power 32.4%, coal 19.7%, LNG 22.5%, renewable energy 21.6%, hydrogen and ammonia 2.1% by 2030. However, the Korean government aims to further expand the utilization of both nuclear power and renewable power generation by 2036.
