

### Summary report on photovoltaic energy storage policies

Should guidance on solar PV be included in the National Policy Statement?

The solar industry very much welcomes the addition of guidance on solar PV to the National Policy Statementfor renewable energy infrastructure. However, there are several provisions which could be strengthened, which we have outlined below.

#### Is solar PV a strategic renewable technology?

This report clearly points out that solar PV is one of the strategic renewable technologies needed to realise the global energy transformation in line with the Paris climate goals. The technology is available now, could be deployed quickly at a large scale and is cost-competitive.

Why are standards important in the solar PV industry?

Box 9. THE IMPORTENCE OF STANDARDS IN THE SOLAR PV INDUSTRY Standards are essential for ensuring safety and quality in the solar PV sector, especially because the reliability, performance and durability of solar equipment is critical to ensuring smooth operation of solar power plants.

Should a target for solar generation be included in the NPS?
